An Executive Session of the Board of Education is a portion of a meeting that is not open to the public. These are held periodically for a limited number of specific purposes, as set forth by law, as follows:

- **Matters that will imperil the public safety if disclosed.**
- **Any matter that may disclose the identity of a law enforcement agent or informer.**
- **Information relating to current or future investigation or prosecution of a criminal offense that would imperil effective law enforcement if disclosed.**
- **Discussion involving proposed, pending, or current litigation.**
- **Collective negotiations pursuant to Article 14 of the Civil Service Law.**
- **The medical, financial, credit, or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal, or removal of a particular person or corporation.**
- **The preparation, grading, or administration of exams.**
- **The proposed acquisition, sale, or lease of real property or the proposed acquisition, sale, or exchange of securities, but only when publicity would substantially affect the value of these things.**

An Executive Session can take place only upon a majority vote of the total membership of the Board taken at an open meeting.

All community members are welcome and encouraged to attend meetings.
