We currently meet the FCC bandwidth standard. We have a connection with a guaranteed 200Mbps maximum for our 1600 students. We have had full wireless coverage in all four of our buildings for many years now. We anticipated the growing need for wireless back then and outfitted our buildings accordingly. The current equipment is aging and in need of replacement. We also need to be able to support greater device density and provide higher throughput available with newer access points.

Years ago we completed upgrading and expanding our wireless network in anticipation of wide spread use of wireless devices and a one-to-one program. The current system has served us well for the years that we've had it in place. However the equipment is aging. We're planning on replacing all of the existing access points with newer devices. We will also be replacing some of our network switches where needed to support this upgrade. As with any technology, the newer access points will allow for faster connections for our students and staff. That's important as we see more and more usage of high bandwidth resources like video and AR/VR in the classroom. The newer wireless infrastructure with support for new wireless standards will also allow us to support greater device density in a given area without having to add additional access points.

Our first two Smart Schools Investment Plans allowed us to provide our 6th through 12th grade students will one-to-one devices. While we do have wireless access in each classroom our wireless access points were installed years ago and do not support the newer, faster protocols and throughput that our newer devices are capable of. As teachers discover new and exciting ways to incorporate the use of bandwidth intensive activities like online videos, virtual reality, and virtual field trips with live video it is important to us to ensure that our network us up to the challenge of providing a fast, reliable connection on which they can count on when it comes time to start their lesson. Our aim in this SSIP is to begin the process to ensure we can provide that for them.

This plan directly addresses this very concern. As stated in the previous question, we do have a wireless network in place that covers every classroom. It was installed years ago and does not support the latest protocols like 802.11AC and the coming Wifi6 speeds that our devices will be capable of. Wireless technology is always getting faster and these newer standards just were not around at that time . Approval of this plan will help us get started upgrading those older access points to more current models.
